Whereas the patents-in-suit in this matter are also the subject of litigation in *ParkerVision, Inc. v. Apple Inc., et al.*, 3:15-cv-1477-BJD-JRK (M.D. Fla); and

Whereas the parties seek to preserve judicial resources and ensure a uniformity of resolutions; and

Whereas, the Defendants in this action have further agreed to be bound by the final claim construction order entered in *ParkerVision, Inc. v. Apple Inc., et al.*, 3:15-cv-1477-BJD-JRK (M.D. Fla.), in exchange for the Plaintiffs staying this action.

**IT IS NOW FURTHER STIPULATED AND AGREED**, subject to the approval of the Court, that:

1. Defendants will be bound by the final claim construction order from ParkerVision’s action against Qualcomm and Apple (*ParkerVision, Inc. v. Apple Inc., et al.*, 3:15-cv-

1477-BJD-JRK, M.D. Fla. or in another jurisdiction if 3:15-cv-1477 is transferred or dismissed/refiled); and

2. This action shall be stayed until ParkerVision's action against Qualcomm and Apple (*ParkerVision, Inc. v. Apple Inc., et al.*, 3:15-cv-1477-BJD-JRK, M.D. Fla. or in another jurisdiction if 3:15-cv-1477 is transferred or dismissed/refiled) is resolved with a decision that is final.
